Mr. Markins advised that IPRD along with the Iberville Parish Council would begin replacing deteriorating culverts running underground from Belleview Road toward the concession stand at Belleview Park. The project is scheduled to begin in mid January and be completed by the end of February, weather permitting. The cost of the project would be shared by IPRD and the Iberville Parish Council.

He updated the board on the Bidy Basketball League IPRD is hosting in Plaquemine. Twenty Two teams participated in ages 5 – 12 years. The regular league is ending soon and all star play will begin. He wants to expand the league parish wide this year. The league is sanctioned by National Bidy Basketball.
