Mr. Markins reported our bus trip to the Saenger Theatre in New Orleans to see "*Escape to Margaritaville*" was on October 26th and very successful with a full bus.

A *Princess Party* was hosted and sponsored by IPRD on December 1st. About 75 children attended.
